COMP RESPONDED TO STATION AND EXPLAINED THAT HE HAS COMPLETED POSTS ABOUT POLITICS, HIS TELEVISION APPEARANCES AND FAMILY ITEMS ON HIS FACEBOOK ACCOUNT. COMP CONTINUED THAT HE HAS RECEIVED THREATENING MESSAGES THROUGH FACEBOOK FROM LISTED SUBJECT INCLUDING ONE HE SAVED THAT STATED "YOUR GONNA GET YOUR ASS BEAT I CAN PROMISE YOU THAT". COMP FURTHER CONTINUED THAT SUBJECT ALSO SENT MESSAGES THAT WERE VERY FOUL, VULGAR AND OBSCENE CONCERNING ACTS THAT SUBJECT WAS WATCHING AND OR BEING DONE BY HIS (COMP) DAUGHTER. COMP CONCLUDED THAT HE DID WANT TO SEEK CRIMINAL CHARGES AGAINST SUBJECT.

REP DET SECURED A COPY OF DESCRIBED THREATENING MESSAGE FOR CASE FILE. REP DET ALSO GAINED LICENCE INFORMATION ECT ON SUBJECT BUT COULD NOT LOCATE SUBJECT ON FACEBOOK TO OBSERVE ACCOUNT. REP DET IS TO SECURE A SUPPORTING DEPOSITION FROM COMP ON 6/22 AND ATTEMPT TO CONTACT SUBJECT FOR AN INTERVIEW.

ON 6/28 REP DET CONTACTED SUBJECT BY PHONE AND ADVISED HIM OF DESCRIBED COMPLAINT. SUBJECT EXPLAINED THAT COMP HAD MESSAGED HIS FATHER OVER POLITICAL THINGS AND HAD MADE A COMMENT ABOUT HIS MOTHER THAT ANGERED HIM. SUBJECT CONTINUED THAT HE DID SEND COMP FACEBOOK MESSAGES THAT WERE "AWFUL" AND UNTRUE. SUBJECT AGREED TO RESPOND TO STATION ON 6/29 FOR AN INTERVIEW.

SUBJECT WAS UNABLE TO RESPOND TO STATION ON 6/29 DUE TO WORK COMMITMENTS BUT RESPONDED ON 7/6/18 (1555 HRS). SUBJECT WAS DIRECTED TO PATROL OFFICE, READ HIS MIRANDA WARNINGS AND HE AGREED TO ANSWER QUESTIONS WITHOUT AN ATTORNEY. SUBJECT CONFIRMED DESCRIBED CONVERSATION WITH REP DET ON 6/28 AND AGREED THAT MESSAGING WITH COMP WAS ON ABOUT 5/21/18. SUBJECT ALSO STATED THAT COMP TOLD HIM TO "WATCH HIS BACK" DURING MESSAGING. REP DET QUESTIONED AND SHOWED SUBJECT THE "SCREENSHOT" OF DESCRIBED THREATENING MESSAGE AND SUBJECT DID ADMIT TO SENDING IT. SUBJECT CONCLUDED THAT HE NEVER MET COMP IN PERSON AND DIDN'T WANT TO CONFRONT HIM. REP DET SECURED A VOLUNTARY STATEMENT FROM SUBJECT AND ISSUED
