ON 4/1/19 REP DET RECEIVED AN E-MAIL FROM C/V EXPLAINING THAT HE HAD RECEIVED ANOTHER (SEE C# 19-905042) THREATENING POST/MESSAGE ON HIS FACE BOOK ACCOUNT. C/V ALSO FORWARDED REP DET A COPY MESSAGE FROM LISTED SUBJECT. IN DESCRIBED MESSAGE SUBJECT CALLED C/V DEROGATORY NAMES AND INDICATED HE WOULD INFLICT BODILY HARM ON C/V IF HE WERE TO MEET HIM. REP DET ALSO SPOKE TO C/V BY PHONE AND HE ADDED HE DID WANT TO COMPLETE A CRIMINAL CHARGE IF POSSIBLE AND SEEK AN ORDER OF PROTECTION.

REP DET OBSERVED SUBJECTS FACEBOOK PAGE AND GAINED ADDITIONAL IDENTIFYING INFORMATION THROUGH INTERNET SEARCHES. REP DET ATTEMPTED FOUR DIFFERENT PHONE NUMBERS FOR SUBJECT AND IMMEDIATE FAMILY BUT RECEIVED NO RETURN CALLS.

ON 4/2/19 REP DET CONTACTED BUFFALO GROVE IL. PD, EXPLAINED LISTED EVENTS AND THROUGH DISPATCH PATROL RESPONDED TO [REDACTED] TO ATTEMPT CONTACT WITH SUBJECT. REP DET LATER RECEIVED A CALL FROM OFFICER CARLSON THAT SUBJECT WAS NOT AT LOCATION AND HE LEFT A NOTE FOR SUBJECT TO CONTACT REP DET.

ON 4/3/19 REP DET RECEIVED A MESSAGE FROM SUBJECT. REP DET CONTACTED SUBJECT AND HE EXPLAINED THAT HE DID NOT "KNOW" C/V BUT HAD SEEN HIM ON TV BRIEFLY IN THE PAST. SUBJECT CLAIMED THAT FOR THE LAST FIVE MONTHS HE HAS BEEN RECEIVING "BLOCKED" OR "ANONYMOUS" INCOMING CALL NUMBERS AND UNKNOWN SUBJECT(S) STATE THEY ARE SUPPORTERS OF MICHAEL CAPUTO AND FRIENDS OF PRESIDENT TRUMP. SUBJECT CONTINUED THAT THE CALLERS THREATEN TO KILL HIM AND CALL HIM DEROGATORY JEWISH NAMES. SUBJECT FURTHER CONTINUED THAT HE DID LOCATE C/V ON FACEBOOK AND SEND HIM DESCRIBED MESSAGE. SUBJECT CONCLUDED THAT HE WAS ANGRY, "WENT A LITTLE OVERBOARD" AND "PROBABLY OVER REACTED" (710.30 NOTICE COMPLETED). SUBJECT WAS ADVISED ON POSSIBLE WARRANT AND ORDER OF PROTECTION BEING ISSUED.

REP DET NEXT CONTACTED C/V AND ADVISED HIM ON DESCRIBED PHONE CALL. C/V CONFIRMED HE WANTED TO SEEK A CRIMINAL CHARGE AND STATED EMPHATICALLY THAT IT WAS UNTRUE THAT ANYBODY AT HIS DIRECTION WOULD HAVE CARRIED OUT DESCRIBED
