**NARRATIVE**

COMP RESPONDED TO STATION ON 3/26/19 AND EXPLAINED THAT HE HAD RECEIVED A THREATENING FACEBOOK MESSAGE ON 3/24/19 AT ABOUT 9:07 PM. COMP CONTINUED THAT HE DID NOT KNOW LISTED SUBJECT BUT DID WANT TO COMPLETE A CRIMINAL CHARGE.

COMP DID SHOW REP DET THE MESSAGE AND FORWARDED SAME TO OBTAIN A PRINTED COPY. THE MESSAGE WAS SENT BY/FROM THE ACCOUNT OF LISTED SUBJECT AND WITHIN MESSAGE SUBJECT CALLED COMP A GENDER-BIAS HOMOPHOBIC RACIST ASS. SUBJECT ALSO MADE THREATS INDICATING IT IS NOT SAFE FOR COMP TO SLEEP AND THAT HE WOULD DREAD THE DAY SUBJECT FOUND OUT WHERE HE LIVED.

ON 3/27/19 AT ABOUT 9:45AM REP DET CONTACTED SUBJECT BY PHONE AND HE IDENTIFIED HIMSELF AS SUBJECT. REP DET EXPLAINED DESCRIBED EVENTS AND SUBJECT DENIED KNOWING COMP AND SENDING ANY MESSAGE TO HIM. REP DET REQUESTED SUBJECT RESPOND TO STATION BUT DID NOT RESPOND TO REQUEST. SUBJECT WAS COOPERATIVE WHILE SPEAKING ABOUT COMPLAINT AND EXPLAINED THAT HE WAS ON HIS FACEBOOK PAGE WHILE SPEAKING WITH REP DET. NEXT SUBJECT EXCLAIMED "HOLY SHIT IT IS ON THERE" REFERENCING DESCRIBED MESSAGE BUT INDICATING/CLAIMING HE DID NOT SEND IT. REP DET AGAIN EXPLAINED REQUEST TO INTERVIEW HIM AT STATION BUT STATED HE COULD SIGN SOMETHING BUT AGAIN INDICATED HE DID NOT SEND THE MESSAGE. REP DET ADVISED SUBJECT ON CRIMINAL SUMMONS, ORDER OF PROTECTION OR POSSIBLE WARRANT PROCESSES AND HE EXPLAINED THAT HE WOULD BE COOPERATIVE. SUBJECT EXPLAINED THAT HE COULD UNDERSTAND A ORDER OF PROTECTION IN THIS SITUATION.

REP DET COMPLETED A SUPPORTING DEPOSITION FROM COMP, 710.30 NOTICE, LISTED CHARGE AND FORWARDED SAME TO COURT FOR POSSIBLE CRIMINAL SUMMONS.
