R/O RESPONDED TO THE WINE SELLARS STORE LOCATED AT LISTED ADDRESS FOR A CUSTOMER TROUBLE COMPLAINT. SGT. WANAT WAS ON LOCATION AND OFFENDER WAS ESCORTED OUT OF THE STORE AND WAS ARRESTED FOR REFUSING TO LEAVE THE STORE UPON MANAGEMENT REQUEST. OFFENDER WAS HANDCUFFED WITHOUT INCIDENT BY SGT. WANAT. R/O SPOKE TO WIT2 WHO IS THE ONE THE OWNERS OF THE STORE REPORTED THAT OFFENDER ENTERED THE STORE WITHOUT A MASK. WIT2 CONFRONTED OFFENDER AND ADVISED OFFENDER THAT HE HAD TO PUT ON A MASK TO SHOP IN THE STORE. OFFENDER WALKED PAST WIT2 AND REFUSED TO COMPLY. WIT1 AND WIT2 ALSO ASKED THE OFFENDER TO PLACE A MASK ON AND OFFENDER REFUSED TO COMPLY. OFFENDER STARTED RANTING ABOUT HIS RIGHT TO SHOP IN THE STORE AND STARTED A DISTURBANCE CONFRONTING OTHER CUSTOMERS WHO WERE IN THE STORE. WIT1 THEN ASKED OFFENDER TO LEAVE THE STORE SEVERAL TIMES AND OFFENDER REFUSED. WIT2 ADVISED OFFENDER TO LEAVE OR SHE WAS CALLING THE POLICE. OFFENDER CONTINUED BEING IRATE AND CONFRONTATIONAL, STILL REFUSING TO LEAVE. SGT. WANAT THEN ARRIVED AND GAVE THE OFFENDER SEVERAL OPPORTUNITIES TO LEAVE THE STORE AND EXPLAINED THE PURPOSE OF THE REQUEST AND OFFENDER REFUSED TO COMPLY AFTER SEVERAL MORE REQUESTS BY SGT. WANAT TO LEAVE. SGT. WANAT ASKED MANAGEMENT IF THEY WANTED OFFENDER ARRESTED FOR TRESPASS AND MANAGEMENT SIGNED A DEPOSITION. OFFENDER WAS ESCORTED OUT AND WAS TRANSPORTED TO HQ BY PO MAGGIO VIA CAR #3. OFFENDER WAS BOOKED AND RELEASED ON AN APPEARANCE TICKET PER SGT. WANAT. OFFENDER WAS ALSO ADVISED ON BEHALF OF STORE MANAGEMENT THAT OFFENDER WAS NO LONGER WELCOME IN THE ESTABLISHMENT. LISTED VEHICLE WAS TOWED BY FIRST CHOICE TOWING INCIDENTAL TO LISTED ARREST AND EXPIRED REGISTRATION.
